RULES AND TEAM INFORMATION

1. **Running Clock:** Coordinators at fields will coordinate each fields starting times. Teams are responsible to be on field ready to play prior to start time. There is NO grace period.
2. **Substitution:** Teams sub on the fly. Players leaving the field must be within a few yards of sideline BEFORE sub may enter. Infractions are at the sole discretion of referee. Restart is a direct kick.
3. **Goalkeepers:** There are NO goalkeepers in this tournament. An arc will be in front of the goal within which a player may not stand. Players touching ball inside arc will result in PK.
4. **Roster Size:** Each team may only register a maximum 5 players on each squad. Players MAY NOT be doubled rostered.
5. **Game time:** Each game is 25-minutes, running time. No halftime.
6. **Fouls:** All fouls are restarted by a direct kick. Opposing players must be 2-yards away from ball.
7. **Offsides:** There is NO OFFSIDES.
8. **Ball out of play:** Each field plays touchlines. All restarts are direct: corners, six kicks, kick-ins (throw-ins)
9. **Six Kick:** You may score on a six kick. No half way line rule.
10. **Slide Tackling:** Absolutely no slide tackling permitted. Slide tackling anywhere on the playing field will result in a PK.
11. **PK's:** Any need for a PK, the ball will be spotted at midfield. Player has a free kick into empty net from that distance.
12. **Teams:** A club team may register more than one team in their age bracket. However, they may not share players, regardless of injuries or any other reason.
13. **Ceiling:** Any ball off the ceiling/lights will be restarted with a direct kick for the opposing team at a point perpendicular to ball hitting ceiling.
14. **Registration:** 1 team representative must register team(s) at least 30-minutes prior to first game.
15. **Food/Drink:** No food or drink is permitted at all. A full concession stand is available for your convenience. Absolutely no food or drink is permitted in any gym.
16. **Waivers:** All players must sign a waiver form, which will be checked at registration.
17. **Protests:** Absolutely, positively, there will be NO PROTESTS of any kind. PERIOD.
18. **Fans:**
  - a. Main Gym – All fans must be on second floor level in viewing areas. Only coaches, players and assigned personnel permitted in gym.
  - b. Aux Gym – fans may stand in area along touchline against the wall at their own admission to risk of injury due to players and balls being close to them.
  - c. This is a charity tournament. Any fans deemed to be portraying any unsportsmanlike conduct will be asked to leave the building.
  - d. There is no smoking or drinking alcoholic beverages anywhere on the Parkland High School Campus.
19. **Age Brackets:** We reserved the right to combine age brackets if needed to make any age bracket successful. Age brackets two years apart WILL NOT be combined.
20. **Disclaimer:** Parkland High School is not sponsoring this event nor affiliated with it.
